



## 2022 APPLICATION FOR EQUINE ASSOCIATION OFFICIALS

( BE A MEMBER & RENEW EARLY - INSURANCE EXPIRES JANUARY 1<sup>ST</sup> EACH YEAR )

Membership in your Provincial Equine Association enables you to apply for low cost broad coverage insurance for any officiating and course design.

CapriCMW Insurance is the official insurance broker of most Equine Associations in Canada.

### Liability Insurance for Officials and Course Designers

- Some Clubs may not be participating in our insurance program or may not have renewed their insurance yet. Clubs who have arranged insurance outside our program may not have coverage for Officials. If you do any officiating outside your Province or outside Canada, there is no way of knowing what insurance may be in place for you as arranged by the group hosting the event.
- The Insurance Program provides \$5,000,000. Commercial General Liability. The insurance provides coverage for "Provincially approved" and E.C. certified Officials who are officiating at events held by others. This means you do not have to worry about the insurance carried by event hosts.
- The coverage extends world-wide for officiating in jurisdictions where E.C. rules and regulations apply as a minimum standard and also covers course design.
- The cost of this insurance coverage is \$200 and is contingent on the attached form being completed and returned to CapriCMW Insurance for "approval". This must be done prior to being covered.

**If you want coverage** please complete and return the attached form to CapriCMW Insurance using the enclosed addressed envelope. Remember to also enclose your \$200 premium payment as coverage is not effective until we receive both the signed application form and the premium payment.
